



## REQUEST FOR PROPOSAL (RFP) METAL FABRICATION SERVICES FOR INDUSTRIAL SITE

### 1. INTRODUCTION

Guyana Shore Base Inc. is seeking proposals from qualified metal fabrication contractors to provide metal fabrication services at our industrial facilities located in Plantation "A" Houston District Georgetown. This RFP outlines the requirements, scope of work, submission guidelines, and evaluation criteria for interested bidders.

### 2. PROJECT OVERVIEW

The scope of this project includes the design, fabrication, delivery, and installation of various metal components and structures necessary for the expansion, upgrade or repair of facility assets. These components may include, but are not limited to:

- Variety of metals (Stainless steel, Aluminum, carbon steel, galvanized steel)
- Utilization of various welding methods (MIG, TIG & Arc)
- Structural steel frameworks
- Steel platforms, stairs, handrails, and walkways
- Custom enclosures and housing
- Pipe supports and brackets
- Sheet metal ducting and guards

Tasks will require on-site & off-site work

### 3. SCOPE OF WORK

The selected contractor will be responsible for:

- Design review and shop drawings (as required)
- Material procurement (in compliance with project specifications)
- Fabrication in accordance with applicable codes and standards (e.g., AWS, ASTM, ISO)
- Surface preparation and coating/painting
- Quality assurance and control inspections
- Packaging, transport, and delivery to site
- On-site installation and erection
- Compliance with safety and environmental regulations

All work must meet the specifications and standards provided in the project drawings and technical documents (to be shared during the bidding process).



## **4. PERSONNEL REQUIREMENTS**

- Specific requirements will depend on task specifications
- Relevant certifications (e.g., ASME, AWS, ISO) must be submitted when required
- All fabrication and repair to lifting equipment requires G6 certification

## **5. INSPECTION & TESTING REQUIREMENTS**

All welded and fabricated components must undergo the following test (as applicable)

- Visual Inspection
- Magnetic Particle Testing (MT) or Dye Penetrant Testing (PT)
- Load Testing for components associated with lifting or structural use

Final acceptance is contingent upon successful issuance of test certificates

## **6. PROPOSAL REQUIREMENTS**

Bidders must include the following in their submission:

- Company profile and relevant experience in Oil & Gas industry
- Details of similar past projects (minimum 3 references)
- Proposed project team and qualifications
- Fabrication facility capabilities and equipment list
- Itemized rate sheet detailing labor, equipment & overhead costs
- Safety records and quality control procedures
- Any assumptions or exclusions

## **7. EVALUATION CRITERIA**

Proposals will be evaluated based on:

- Technical approach and understanding of the scope
- Experience and past performance on similar projects
- Fabrication capabilities and resources
- Compliance with standards and safety requirements
- Cost competitiveness

## **8. REQUIREMENTS FOR QUOTATION SUBMISSION**

Interested contractors must provide the following documents:

- Local Content Certificate (if available). If no Local Content Certificate is available, Guyanese-registered businesses can provide evidence of majority-Guyanese ownership and indication that local content certification is being or will be pursued.
- Valid Business Registration or equivalent
- Valid GRA & NIS Compliance
- Any Other Certification
