1. INTRODUCTION

Guyana Shore Base Inc. (GYSBI) invites qualified and experienced bidders to participate in this Request for Proposals (RFP) for the Provision of GWI Water Supply and Distribution Infrastructure at the GYSBI Industrial Estate located at McDoom, Georgetown.

2. PROJECT OVERVIEW

- Location: GYSBI Industrial Estate, McDoom, Georgetown
- Scope: Complete works for the supply and installation of HDPE waterlines of 2" diameter and 4" diameter (iron pipe size) for respective distances of 354m and 266m along with the construction of a buried reinforced concrete reservoir 9.65m x 4.76 m.
- Objective: Supply and install HDPE waterlines and construct a buried reinforced concrete reservoir that complies with the Company's requirements and relevant standards.
- Key Considerations:
 - Strict compliance with GYSBI's Health, Safety, and Environmental (HSE) protocols.
 - Incorporation of modern technologies and methodologies to support fast-track construction and cost-effective delivery.
