1. INTRODUCTION

2. PRODUCT REQUIREMENTS

- Delivery Location: Annex Warehouse facility at McDoom, East Bank Demerara, Georgetown
- Objective: Cleaning of Wash Bay Tanks.
- Key Consideration: See Scope of work below.

3. REQUIREMENTS FOR QUOTATION SUBMISSION

Interested contractors must provide the following documents:

- Local Content Certificate (if available). If no Local Content Certificate is available, Guyanese-registered businesses can provide evidence of majority-Guyanese ownership and indication that local content certification is being or will be pursued.
- Valid Business Registration or equivalent
- Valid GRA & NIS Compliance
- Any Other Certification

5. WASTE/SLUDGE COMPOSITION

- **Characteristics:** Chemical and biological contents include hydrocarbons, heavy metals, and caustic/acidic residues (per SDS Composition/Information on Ingredients).
- **Safety Data:** MSDS/SDS documents attached for reference.
- **Hazardous Classification:** Confirmed as hazardous waste.
- **Flammability/Corrosiveness/Toxicity:** Limited flammability data; most substances are irritants.

6. CLEANING SPECIFICATIONS

- **Access:** Manways; confined space entry; working at height involved.
- **Method:** Suction with vacuum truck (manual/hydro/chemical cleaning not required).
- **Hot Work:** Not required; cold work permits only.
- **Ventilation/Gas Testing:** Not required.

7. PPE & SAFETY REQUIREMENTS

- **Required PPE:** Tyvek suits, gloves, hardhats, safety glasses, steel-toed boots, and body harnesses.
- **Decontamination:** Not required post-task.
- **Controls:** No confined space safety watch required; standard cold work procedures to be followed.

8. TANK INFORMATION

- **Construction:** Carbon steel/fiberglass (to be confirmed).
- **Access Points:** Standard manways.
- **Sludge History:** Loose sludge, no prior cleaning issues noted.

9. FREQUENCY & TIMING

- **Cycle:** Quarterly cleaning.
- **Schedule:** During facility downtime, 07:00–17:00.



10. WASTE DISPOSAL REQUIREMENTS

- **Transport:** Certified waste haulers/vacuum truck only.
- **Treatment:** Sludge must be treated per disposal facility guidelines.
- **Disposal materials:**
 - Oily water
 - Sludge
- **Compliance:** All work must align with EPA and local waste regulations.

11. DELIVERABLES FROM SUPPLIER

- Cleaning methodology.
- Risk Assessment & Method Statement (RAMS).
- Waste manifest/treatment certificates.

12. WORK BREAKDOWN

1. **Initial Setup**
 - Mobilize vacuum trucks to site.
 - Conduct safety briefing and verify permits.
 - Connect vacuum truck to quick-connect valve on Processed Water Tank.
2. **Oily Water Removal**
 - Suction oily water from Processed Water Tank.
 - Continue suction from Filter Tank until truck capacity is reached.
 - Transport oily water for disposal.
3. **Sludge Removal**
 - Suction Sludge from Processed Water Tank.
 - Suction sludge from filter tank.
 - Transfer sludge truck to IBC tanks
 - GYSBI transport of Sludge to waste facility
