

REQUEST FOR PROPOSALS (RFP)

FABRICATION AND DELIVERY OF PRESTRESSED CONCRETE PANELS

1. INTRODUCTION

Guyana Shore Base Inc. invites qualified suppliers to submit pricing for the fabrication and delivery of five (5) prestressed concrete replacement panels in accordance with the Prestress Panel Design Drawing - IFP.

2. SCOPE OF SUPPLY

Supplier shall provide all labor, materials, prestressing operations, QA/QC, and delivery required for:

- Five (5) prestressed concrete panels:
- Prestressing strands: per S1.
- Reinforcing steel: per General Notes.
- Embedded components
- Surface finish: Troweled per CS2.
- All formwork, inserts, chairs, spacers, and lifting hardware.
- Delivery to GYSBI site, coordinated with GYSBI.

3. TECHNICAL REQUIREMENTS

Fabrication shall comply with all notes on CS2 and S1, including:


- Concrete Requirements (Ref. CS2 Concrete Notes)
- Concrete compressive strength: 8,000 psi @ 28 days
- Thorough mechanical vibration and consolidation
- Slump and placement per General Notes
- Panels cast monolithically
- Prestressing (Ref. S1 Details)
- Prestress layout, strand count, and drape per drawing
- Full tension logs required as submittals
- Reinforcement (Ref. CS2 Reinforcing Steel Notes)
- New deformed billet steel, ASTM A615 Gr. 60
- Minimum development lengths per ACI 318
- Bars tied securely; proper spacers/chairs required
- Dimensional Requirements (Ref. S1)
- All dimensions and conduit/sleeve locations must match drawings precisely
- Any discrepancies to be reported prior to fabrication

4. DOCUMENTATION

Supplier must provide:

- Material certificates (cement, aggregates, rebar, strands)
- Concrete mix design for 8000 psi class
- Prestress procedure and tensioning logs
- QC testing results (slump, cylinders, 7-day & 28-day breaks)
- Final inspection/measurement report
- Delivery method statement

5. DELIVERABLES

- Five completed prestressed concrete panels
- Complete QA/QC documentation package
- Material certifications and test results
- Delivery to GYSBI
